2019 Community Health Needs Assessment

Insight into Thomas H. Boyd Memorial Hospital's population

Provisions in the Affordable Care Act (ACA) require charitable hospitals to conduct a Community Health Needs Assessment (CHNA). The CHNA is a systematic process involving the community to identify and analyze community health needs as well community assets and resources in order to plan and act upon priority community health needs.

This assessment process results in a CHNA report that assists the hospital in planning, implementing, and evaluating hospital strategies and community benefit activities. The Community Health Needs Assessment was developed and conducted in partnership with representatives from the community.

This Community Health Needs Assessment will serve as a guide for planning and implementation of healthcare initiatives that will allow the hospital and its partners to best serve the emerging health needs of Carrollton and the surrounding area.

Introduction/Background

Thomas H. Boyd Memorial Hospital dba Boyd Healthcare Services is a 25 bed not for profit Critical Access Hospital. It was opened in September 1941, as an acute care hospital and in 1999 became the first critical access hospital in the State of Illinois. The hospital is licensed by the Illinois Department of Public Health. The hospital maintains a medical unit with a 24 hour Emergency Room Department. We provide primary care in four hospital based certified rural health clinics in four communities in the county. We also manage the only ambulance service located in Greene County. The hospital employees over 156 employees.

Thomas H. Boyd Memorial Hospital completed two Community Health Needs Assessments prior to 2019. The first CHNA was conducted in 2013 and it identified four different needs.

- 1. Basic wellness services, education and access for all residents
- 2. Mental Health Issues
- 3. Addressing access to quality local health care
- 4. Teen pregnancy.

The second CHNA was conducted in 2016 and identified three needs.

- 1. Wellness and Prevention
- 2. Mental Health and Substance Abuse
- 3. Education on key areas: Diabetes, Congestive Heart Failure, Chronic Obstructive pulmonary Diseased, Cardiovascular Disease/Stroke and Cancer.

In response to these prior needs assessments, Thomas H. Boyd Memorial Hospital

- Implemented an indoor walking trail
- Added Locust Street Resource Center with staff here at the hospital weekly
- Added new physicians and mid-level providers to the four hospital based certified rural health clinics
- Offered tele-health services through STAT STROKE and STAT HEART
- Offered tele-health clinic services
- Obtained grants on the reduction of salt throughout the hospital, schools and public
- Offering educational programs on Stroke, Diabetes, Heart Disease, Alzheimers and COPD
- Offering yearly health fair with testing and educational materials
- Have begun offering classes in different areas of the county,
- Working with Locust Street to have a substance abuse counselor in the County 3 days a week
- Working with local staff to address prescription abuse. Have medication agreements, utilize the prescription monitoring program, and drug testing.
- Established a Chronic Care Management program and a Transitional Care management program.

Executive Summary

Thomas H. Boyd Memorial Hospital dba Boyd Healthcare Services conducted a Community Health Needs Assessment (CHNA) during the spring of 2019. Administration worked to complete this process to identify and analyze the community's health needs and update the community's resources to prioritize the health needs of our community. The CHNA is influenced by the large rural service area of Thomas H. Boyd Memorial Hospital.

The health profile of the service area of Thomas H. Boyd Memorial Hospital is influenced by the following indicators of social determinants of health:

- 1. Poverty Children living in poverty
- 2. Poverty Population below 100% of Federal Poverty Level
- 3. Unemployment
- 4. Access to mental healthcare
- 5. Access to dental care of low income, underinsured and uninsured.

Community Health Needs Assessment Population

A total of 69,277 people live in the 1,910.68 square mile report area defined for this assessment according to the U.S. Census Bureau American Community Survey 2013-17 5-year estimates. The population density for this area, estimated at 36.26 persons per square mile, is less than the national average population density of 90.88 persons per square mile.

Household Composition

Social & Economic Factors - Economic and social insecurity often are associated with poor health. Poverty, unemployment, and lack of educational achievement affect access to care and a community's ability to engage in healthy behaviors. Without a network of support and a safe community, families cannot thrive. Ensuring access to social and economic resources provides a foundation for a healthy community.

Children Eligible for Free/Reduced Price Lunch

Within the report area 6,027 public school students or 51.13% are eligible for Free/Reduced Price lunch out of 11,787 total students enrolled. This indicator is relevant because it assesses vulnerable populations which are more likely to have multiple health access, health status, and social support needs. Additionally, when combined with poverty data, providers can use this measure to identify gaps in eligibility and enrollment.

Education - Bachelor's Degree or Higher - 16.6% of the population aged 25 and older, or 8,122 have obtained a Bachelor's level degree or higher. This indicator is relevant because educational attainment has been linked to positive health outcomes.

In the Report Area, there is a total population of 48,929 ages 25+, out of those 8,122 have a Bachelor's Degree or higher. This put the percentage at 16.6% which is well below the state average of 33.45%. Below is a look at each county in our CHNA:

Calhoun County – population Ages 25+ is 3,524, the population with a BA or higher is 484 which is 13.73%.

Greene County – population Ages 25+ is 9,378, the population with a BA or higher is 1,125, which is 12%.

Macoupin County – population Ages 25+ is 32,422, the population with a BA or higher is 6,011, which is 18.54%.

Scott County – population Ages 25+ is 3,605, the population with a BA or higher is 502, which is 13.93%

Education - Student Reading Proficiency (4th Grade) - This indicator reports the percentage of children in grade 4 whose reading skills tested below the "proficient" level for the English Language Arts portion of the state-specific standardized test. This indicator is relevant because an inability to read English well is linked to poverty, unemployment, and barriers to healthcare access, provider communications, and health literacy/education.

Insurance - Uninsured Population

The lack of health insurance is considered a key driver of health status.

In the report area 6.08% of the total civilian non-institutionalized population are without health insurance coverage. The rate of uninsured persons in the report area is less than the state average of 8.52%. This indicator is relevant because lack of insurance is a primary barrier to healthcare access including regular primary care, specialty care, and other health services that contributes to poor health status.

In Calhoun County, the uninsured population can be broken down to 4.03% male, 2.82% female. It is also further specified as 0.64% being under the age of 18, 5.93% are 18-64 years of age and 0% are 65+.

Greene County breaks down to 8.31% male, 7.56% female. 5.72% are under the age of 18, 11.32% are between the ages of 18-64 and 0% are above 65.

Macoupin County is 6.84% male, 4.82% female. The age groups are 2.28% under the age of 18, 8.98% are between the ages of 18-64 and 0% are above 65 years old.

Scott County uninsured are 8.33% male and 4.12% female. The age groups are 1.33% under 18, 9.93% from 18-64 years old and 0.75% over the age of 65.



Macoupin County and Scott County both have a higher percentage for females, 23.69% and 19.8% respectively and males are 18.28% and 18.86%.

Behavioral Risk Factor Surveillance System — The BRFSS is the largest, continuously conducted telephone health survey in the world. US Census – National census data is collected by the US Census Bureau every 10 years.

County Health Rankings – Each year, the overall health of each county in all 50 states is assessed and ranked using the latest publicly available data through a collaboration of the Robert Wood Johnson Foundation and the University of Wisconsin Population Health Institute.

Community Commons – Community Common is an interactive mapping, networking and learning utility for the broad-based health, sustainable and livable communities' movement.

Illinois Department of Employment Security – The Illinois Department of Employment Security is the state's employment agency. It collects and analyzes employment information.

National Cancer Institute – The National Cancer Institute coordinates the National Cancer Program, which conducts and supports research, training, health information dissemination, and other programs with respect to the cause, diagnosis prevention, and treatment of cancer, rehabilitation from cancer, and the continuing care of cancer patients and the families of cancer patients.

HRSA – The Health Resources and Services Administration of the U.S. Department of Health and Human Services develops health professional shortage criteria for the nation and uses that data to determine the location of Health Professional Shortage Areas and Medical Underserved Areas and Populations.

ESRI – (Environmental Systems Research Institute) allows for specialized inquiries at the zip code or other defined level.

QUALITATIVE DATA

Qualitative Data was reviewed to help validate the selection of health priorities. In alignment with IRS Treasury Notice 2011-52,2 and the subsequent final rules reported at 79 FR 78953, the qualitative/primary data received and reviewed included primary input from (1) At least one state, local, tribal or regional governmental public health department (or equivalent department or agency) with knowledge, information, or expertise relevant to the health needs of the community and, (2) members of medically underserved, low-income and minority populations in the community or individuals or organizations serving or representing the interests of such populations.

No written comments were received concerning the hospital facility's most recently conducted CHNA nor on the most recently adopted implementation strategy.

Data was also gathered representing the broad interests of the community. The hospital took into account input from persons who represent the broad interest of the community served by the hospital, including those with special knowledge of, or expertise in public health (local, regional, state and/or tribal).

Members of the CHNA committee, who participated in focus groups and the needs identification and prioritization process, were chosen based on their unique expertise and experience, informed perspectives, and involvement with the community. A notice was also placed inviting any concerned citizens to participate in the focus meetings in each community.

Focus Groups

The first focus group met on Tuesday, June 18, 2019 at the Greene Gables Inn in White Hall at 8:00 am. This group consisted of community leaders and representatives of groups that represent and/or serve persons that may be underserved by local medical services. The mayors, School superintendent, business leaders and random members of the community participated.

D. Campbell, CEO, started with introductions and an explanation of the CHNA program. The two previous CHNA reports were reviewed with questions regarding the positive developments in recent years for the healthcare needs.

- Boyd Hospital working closely with Locust Street in providing Mental Health services
- 911 consolidation involving Greene, Calhoun and Morgan counties
- Expanded Cardiac and Pulmonary Rehab at the hospital
- Helicopter based at Thomas H. Boyd Memorial Hospital

Description of the Community Health Needs Identified with Implementation Strategies

After a review of all notes from the focus groups and the summaries of data reviewed, we have identified and prioritized the following as being the significant health needs facing the Thomas H. Boyd Memorial Hospital service area. As the needs were identified, implementation strategies were discussed.

1. Mental Health

- a. Better access to local mental health services and providers
- b. Education for the community on mental health awareness and the stigma of mental health.
- c. Work with the schools and Locust Street to provide better resources in the community

Actions the hospital intends to take to meet this health need:

- Continue to work with Locust Street for counseling and other services
- Create an educational program and materials on local mental health needs
- Explore recruiting a psychiatric nurse practitioner

2. Substance Abuse drugs/controlled substances

- a. Continue working through the clinics with the drug contracts, drug testing counseling, pain management and reduction of medications.
- b. Utilize Locust Street's Substance Abuse Counselor
- c. Work with the schools, Locust Street, and local police to provide education for staff and the community

Actions the hospital intends to take to meet this health need:

- Continue to work with Locust Street's Substance Abuse Counselor, the four rural health clinics and law enforcement to promote substance abuse prevention
- Provide education programs for the local community and schools
- 3. Provide improved local access to specialist services through our tele-health program. This would include:
 - a. Dermatology
 - b. Neurology
